



Data Privacy Statement

In accordance with the EU General Data Protection Regulation (GDPR) effective as of 25 May 2018, the Parent(s)/Guardian(s) and Student must give their consent for the collection and use of the following data. Once signed, this consent form is valid for the duration of the student's time at AMADEUS.

Personal data will not be passed on to third parties unless:

- AV is legally required to do so
- The Parent(s)/Guardian(s) and the Student have given their consent
- Required by medical authorities in the event of an emergency medical situation
- They have been requested by another educational institution to which the student is applying and parent/guardian permission is given

The Parent(s)/Guardian(s) and the Student retain the right:

- To access all personal information pertaining to them held by AV
- To request that AV correct any inaccurate personal information concerning them
- To request that AV delete their personal information
- To restrict or object to the use of their personal information by AV

Consent for the use of any or all personal data can be restricted or revoked by the Parent(s)/Guardian(s) and the Student at any time in written form, apart from those data that AV is legally required to maintain for the conclusion and enforcement of the school contract and to comply with Austrian law (**listed "internal" below**).

Parent(s)/Guardian(s) and the Student may indicate in writing which data for the **external** purposes of advertising and school promotion they do not permit AV to collect and use (**listed "external" below**).

This document is valid for the duration of the Student's studies at AV.

AV confirms that all technical and organizational measures are taken to protect the rights covered by the GDPR and to fulfil the obligations under the GDPR.

Internal Use: For use in admissions processes, to ensure the health and safety of the student, for daily administrative and educational operations (including boarding operations, if applicable), and for internal statistical analysis:

- Name
- Age/Grade
- Gender
- Date of Birth
- Place of Birth
- Nationality/Citizenship
- Contact details of both the student and parent(s)/guardian(s)
- Payment/bank details
- Medical information
- Previous educational information/records/transcripts/reports
- Photos/Video/Audio
- School work
- Results of standardized tests and other assessments

External Use: To be used for advertising and school promotion through the use of school website, partner websites, newsletters, articles in print media, school promotion videos, website blogs, AV YouTube channel, and AV social media.

For statistical purposes in advertising the school:

- Age/Grade
- Gender
- Date and place of Birth
- Nationality/Citizenship

For advertising student activities and accomplishments on the website and in AV newsletters:

- Photos, Video and Audio
- Accomplishments
- Results of standardized tests and other assessments (not individual student scores, rather student aggregates)

The following are examples of how data would be used for external purposes:

<p>School Website</p> <p>Statistical information such as; „AMADEUS students represent 47 different nationalities.“, “AMADEUS students are among the top 10% of their peers on standardized tests”, etc. Photos from events, e.g. Winter Wonderland and photos on the AV Website.</p>	<p>School Website Blog</p> <p>Student accomplishments and personal work published as News Items in the school blog. Sharing the story of student led projects such as art exhibitions and club meetings via the school website blog.</p>
<p>Newsletters</p> <p>Feature articles about/by students and photos of AMADEUS activities such as excursions, student led projects, events, etc.</p>	<p>Promotional Videos</p> <p>Professional videos made to promote AMADEUS in the public and recruit prospective students.</p>
<p>AV Social Media</p> <p>Daily school activities and student projects shared with AMADEUS followers via Facebook, Instagram, and Twitter</p>	<p>AV YouTube Channel</p> <p>Student performances such as AV GALA, recitals, lessons, etc. AMADEUS events and school promotional videos.</p>
<p>Student Recruitment & Partner Websites</p> <p>Sharing of AV promotional material with student recruitment agents and partners. Articles spotlighting school and students on partner websites.</p>	<p>Articles in Print Media</p> <p>Feature articles spotlighting the school and student accomplishments in publications.</p>

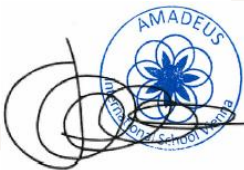
